Future Licensing and Regulation of Private Investigators in the UK

At this time, there is a lot of confusion as to what is happening with regard to the licensing of the private investigation industry and, unfortunately, this is putting off many people who want to enter the profession and start their own investigation agencies. This is mainly due to the uncertainty of what is actually happening and the worry of wasting a lot of money on an expensive training course that is ultimately likely not to be acceptable for obtaining a license, if or when, they may be introduced.

The UKPIN have realised this problem and to facilitate potential students that wish to start an investigation agency now, or in the very near future, have drastically reduced the price of its investigation training course to allow them to do so without the risk of high financial loss. THE CURRENT LICENSING SITUATION

There is currently no licensing or regulation of the private investigation industry in the UK and anyone can set up as a private investigator and start trading immediately.

The Home Secretary Theresa May has stated that The Private Security Industry Act 2001 defines the licensable activities of private investigations and The Home Office intends to review this definition to ensure that it remains fit for purpose.

As recently as April 2014, she has stated that the SIA would license private investigators. However it's not likely that the Coalition will do either before the election.

Some of the measures she intends to put in place need a new law, such as giving the regulator the power to impose fines, rather than going through the courts - this does need new primary legislation.

In the light of the "Leveson Enquiry", she is also extremely concerned about adequately protecting personal data and data communications; again, this may require some new legislation to include our industry.

The Home Office has only said that it is working to put such law in place as soon as possible."

The **SIA** is the Security Industry Authority, who will regulate the future licensing of private investigators, after it is passed to them by the Government.

All of these matters are still with Parliament and has yet to be decided upon: before it is even passed in law and then handed over to the SIA for interpretation, implementation and training decisions taken.

We recently spoke to a representative of the SIA who said that it is advising prospective students for private investigation training **NOT** to purchase an expensive training course until the SIA know what the criteria from the Government will be, They stated that it is highly likely that any current courses will not conform to any new training standards and requirements that they may have to bring in and could well be waste of the students money.

The anticipated introduction of licensing, yet again, has officially been put back to next year and there is no definitive or clear indication when licensing will be actually introduced: this has been going on for years. In terms of time, the date by which you will have actually put "pen to paper" and apply for a license could be, at least, 2 to 3 years from now or even longer.

Currently, there is **NO** private investigation course, 'accredited' or otherwise, that can guarantee that you will obtain a license when it is introduced. The new standard has not been defined yet, therefore, it is not possible to create a training course for criteria that does not exist.

WHAT DOES 'ACCREDITED' MEAN?

You should not be confused over the word "Accredited." **It has nothing, whatsoever, to do with the licensing of private investigators.** It simply means that it is recognised by one of the many authorised vocational training organisations that offer and oversee courses, such as a Btec or Level 3 award.
